



Recreation Area Pet Policy

Onslow Beach Recreation Area welcomes you and your pet! Onslow Beach Recreation Area* is pet friendly. For the safety of both you and your pet, please take a moment to review our Pet Policy.

Onslow Beach Recreation Area will follow and require all patrons to adhere to Base Order 10570.1D, "Domestic Animal Control; Dogs, Cats and Horses." For additional information on the Onslow Beach Recreation Area Pet Policy, please refer to the Base Order.

RULES FOR PETS AT ONSLOW BEACH RECREATION AREA

1. All dogs, horses or other animals are required to stay within the authorized area and observe all posted rules and regulations. Animals are not permitted on any Swimming Beach. They are only allowed beach access at the Pet Beach located south of the Sand Dollar Shores Pavilion. Service Animals with proper ID cards are exempt.
2. Specifically excluded animals are:
 - a. Any breeds mentioned in the Prohibited Canine Breeds section of BO 10570.1D:
"Full or mixed breeds of Pit Bulls, Rottweilers, wolf hybrids, or any canine breed with dominant traits of aggression which present an unreasonable risk to the health and safety of persons aboard the Base and therefore are prohibited aboard Base. In cases of mixed breeds and other disputes, the Base Veterinarian's determination will be final and conclusive."
 - b. Ferrets, insects, snakes, any exotic animal or any aquarium larger than 5 gallons.
3. No pets are permitted on or near dunes at any time.
4. Female pets in season are not permitted.
5. Pets are not permitted to run freely anywhere at Onslow Beach Recreation Area. All pets must be kept on a leash that does not exceed ten (10) feet in length. Pets on an appropriate leash are permitted to walk throughout Onslow Beach Recreation Area and at the Pet Beach at owner's risk. Owners are responsible and liable for the actions of their pets at all times.
6. Pets are not permitted to be tied up outside of any unit or left inside any personal vehicle. Any guest found in violation will be reported to the Provost Marshals Office.
7. No more than two (2) pets are permitted per person.
8. Onslow Beach Recreation Area pet-friendly lodging includes selected Lodges, Ospreys, and the handicap accessible unit. Pets are not allowed in any other units. Pet owners found to have pets in non-authorized units must remove the pet immediately and will be charged a \$75.00 per day fee for each day they were in violation.
9. Use of a pet-friendly unit requires a non-refundable \$25 deposit and a fee of 8 per day per pet per day per pet . Pets are restricted to no more than two (2) per unit. Exempted from the deposit and additional fees are: pets staying in personal RV units, any Service Animal with proper ID cards, and fish.
10. When left unattended in the unit, the pet(s) must be confined inside a pet carrier. It is the guest's responsibility to ensure pet(s) are caged when guests are not in the unit. If the guest does not have a carrier, one will be available to them for use at a rental charge of \$20. If at any time it is determined that a pet is not caged and left unattended in the unit, the guest will be asked to leave and forfeit any fees paid for the unit.
11. All dogs and cats will comply with inoculations required in Base Order 10570.1D, Section 4. Proof of a current rabies vaccination is required. A copy of their health record must be provided upon check-in.
12. Pets under four (4) months of age are not permitted because they will not have the necessary inoculations required by the base.
13. Pet owners are required to clean up after their pets and dispose of pet feces in dumpsters in sealed bags. If bringing a cat, you must bring a litter box with you.

14. If a pet is staying in a lodging unit, no food should be left outside the unit at any time. In addition, no food should be left out inside the unit in a bowl overnight. Food attracts pests and may result in an additional pest control charge being applied if an issue is created.

15. Pet owners are responsible for damages caused by their pet(s). Units are inventoried prior to and after each occupancy. Damage discovered as a result of a pet or guest will be billed to the guest at the current replacement cost. Pet owners are also responsible for revenue losses incurred if, after vacating their unit, we are unable to rent the unit as scheduled because of conditions caused by a pet (e.g. urine odors, unusual amounts of animal hair, pests resulting from the pets' visit including ants, roaches or fleas, etc.). Collection actions will be taken if extra cleaning or damages are discovered after departure.

16. The comfort and safety of our guests is important. Complaints from guests received about a pet (e.g., excessive barking, tied up or running loose) shall not exceed one complaint. Should Management receive a second complaint, the guest will be required to make alternate lodging arrangements for their pet(s).

*Onslow Beach defines the actual beach area from the dunes to the shoreline. Onslow Beach Recreation Area is defined as the area from the ICW shoreline to the eastern edge of Ocean Drive.
