

**WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT
UNITED STATES MARINE CORPS**

In consideration of the privilege of using an MCCS Swimming Pool and associated facilities for recreational swimming and other activities at Camp Lejeune, North Carolina, and further recognizing the voluntary nature of my participation in these activities, I, the undersigned person, intending to be legally bound, hereby promise to waive for myself, my guardians, heirs, executor, administrators, legal representatives and any other persons on my behalf, any and all rights and claims for damages, demands, and any other actions whatsoever, including those attributable to simple negligence, which I may have against any of the following persons or entities: the United States of America; the Department of Defense; the Department of the Navy; the United States Marine Corps; Marine Corps Base, Camp Lejeune, North Carolina; Marine Corps Community Services; any and all individuals assigned to or employed by the United States, including but not limited to the Secretary of Defense; the Secretary of the Navy; the Commandant of the Marine Corps; Commanding General, MCIEAST/Marine Corps Base, Camp Lejeune, North Carolina; in both their official and personal capacities; any medical support personnel assigned thereto; and these persons' or entities' representatives, successors, and assigns, ***for any injuries and/or death resulting from my or my minor child's participation in the activities at the MCCS swimming pool***; as well as any use by me of any Marine Corps Base, Camp Lejeune, North Carolina, or Government equipment or facilities in conjunction with and furtherance of such participation by me or my minor child. **I UNDERSTAND THAT I AND/OR MY MINOR CHILD WILL BE USING THE MCCS POOL FOR RECREATIONAL SWIMMING ACTIVITIES. I FURTHER VERIFY THAT I HAVE FULL KNOWLEDGE OF THE RISKS ASSOCIATED WITH USING THE MCCS POOL, TO INCLUDE SLIPPING AND FALLING ON WET SURFACES, OR DROWNING WHILE SWIMMING IN THE POOL. I EXPRESSLY, KNOWINGLY, AND VOLUNTARILY ASSUME THE RISKS INVOLVED IN THE PLANNED ACTIVITIES AND AGREE TO HOLD THE UNITED STATES HARMLESS FOR ANY RESULTING INJURY AND/OR DEATH.** I understand that this waiver of liability/assumption of risk agreement shall remain in effect until notice of cancellation is received by the Commanding General, MCIEAST/Marine Corps Base, Camp Lejeune, North Carolina. I understand that, should I decline to execute this agreement, I will not be permitted to enter the MCCS swimming pool. [**If participant is a minor, a parent or legal guardian must read and provide a signature below.*] I, as the parent or legal guardian of the undersigned minor participant, hereby agree to indemnify the United States Government and all of its agencies, departments and employees against any and all liability, claims, suits, losses, costs, and legal fees caused by, arising out of, or resulting from either the minor's participation in the event, the minor's presence aboard Marine Corps Base Camp Lejeune, or any negligent act by the minor while participating in the recreational swimming activities.
