	The military member must have a valid <u>military ID card</u> to take the test.
	If the service member deploys, go on leave, is released from active service, or assigned temporarily assigned duty (TAD) during the date and time of their assigned test must notify the Military Testing Coordinator, at (910) 451-3092, a <u>MINIMUM</u> of 48 to 24 hours in advance of the assigned test.
