OPI STATEMENT OF UNDERSTANDING

Initial:	<p>1. As per Reference (c), the OPI is a phone conversation with a certified OPI linguist instructor who determines a service member's (Speaking and Listening) proficiency in a foreign language.</p> <p>2. The OPI shall only be approved for Sailors who meet one of the following criteria:</p> <p style="padding-left: 40px;">a. Achieved a minimum Interagency Language Roundtable (ILR) skill level of 3 in both modalities (Listening and Reading) on a computer-based DLPT.</p> <p style="padding-left: 40px;">b. Achieved a minimum ILR skill level of 2 on a one modality computer-based DLPT.</p>
Initial:	Specialized language proficiency assessments are normally comprised of an <u>Oral Proficiency Interview</u> consisting of a <u>30-45 minute phone</u> dialogue between a certified linguist instructor and the military member. Due to the expenses involved, strict adherence to scheduled dates and times are strongly advised.
Initial:	<u>NON-AVAILABILITY DATES FOR THE MILITARY MEMBER:</u> To minimize "NO SHOWS" or "CANCELLATIONS," it is required the military member provide the dates they will not be available for these tests due to deployment, TAD, Leave, PCS orders, or EAS. Please indicate non-availability below:
Initial:	Service members are required to arrive at the designated OPI testing location a minimum of 20 minutes prior to exam administration. Appropriate military identification (current military ID) is required. <u>"NO MILITARY ID, NO TEST."</u>
Initial:	If the service member deploys, goes on leave, is released from active service, or temporarily assigned duty (TAD), during the date and time of their scheduled test, they must notify the Military Testing Coordinator, at (910) 451-3092, a <u>MINIMUM</u> of 48 to 24 hours in advance of the scheduled test date.
