I have read, understand and will abide by the following terms and conditions for using the Resale Lot:

- I understand that there will be a \$30 charge, payable in advance, for each 30-day rental period. Fees are nonrefundable and due upon initial registration and subsequent renewals. Renewals will be based upon availability of space and is not guaranteed.
- I understand that at the end of 30 days I must submit a new Resale Lot Authorization form if I desire the vehicle to remain on the Resale Lot.
- I understand that I may not be allowed to place my vehicle on the Lot for an additional 30-day period if there is a waiting list for the Lot.
- I will ensure the vehicle has current/valid state registration, base registration and NC minimum liability insurance while the vehicle is on the Lot.
- I will ensure the vehicle's Resale Lot parking permit is placed in the driver's window.
- I will ensure the vehicle remains operable, clean, presentable, and does not leak fluids.
- I will only park in designated areas marked off for the Lot.
- I assume all responsibility/liability for any theft, damage or loss while utilizing the Resale Lot.
- I understand that the vehicle will be towed (by civilian wrecker) and stored (in civilian lot), both at my expense, for: expired or no state/base/Resale Lot registration, expired/no insurance, parked in other than a designated area, safety hazard, leaking hazardous material(s), or any other "towable" offense.
- I will not, under any circumstances, perform or allow anyone else to perform maintenance on my vehicle while it is on the Resale Lot.
- I understand that in the event the lot is full I will be placed on a waiting list and contacted when space becomes available.
- I understand that the Resale Lot is off limits during the hours of darkness.

### Registration
